### North Dakota Meat Processing Plant Cost-Share Program

The North Dakota Department of Agriculture (NDDA) is seeking applications for a cost-share program to provide meat processing plants increased capability to meet demand brought on as a result of the COVID-19 pandemic. The program will reimburse processors a portion of expenses dependent on the total amount of eligible applications received and approved through the program.

#### Who is eligible?

State and custom exempt slaughter and processing plants inspected by NDDA

#### Who is ineligible?

- Federally inspected plants
- Grocery stores

#### **Eligibility**

The applicant understands that reimbursement amounts are based upon applicable and reasonable project cost(s) provided by the applicant.

Reimbursements will require actual/copies of receipts, expenses, or invoices. The costs must be incurred between March 1, 2020 through December 15, 2020 to be eligible for reimbursement assistance. The applicant must complete the project, provide proof of work completed, proof of actual expenditure(s), and submit all applicable documents to NDDA by December 15, 2020.

# Improvement items may include, but are not limited to, new or used equipment

- Coolers/Freezers
- Dehydrator
- Hoist Hanger
- Incinerator
- Mixer/Grinder
- Saws/blades

- Scalding tank
- Smoker and cart/sticks
- Stuffer
- Vacuum sealer

Note: multiple improvement items may be included

## Ineligible cost-share items include:

- Construction/remodel
- Installation (some may be eligible)
- Livestock holding facility
- Parts
- Repairs
- Salaries

#### How to apply:

#### Applications are due Nov. 16, 2020, and should include:

- 1. List of equipment purchase(s)
- 2. List of equipment planned to be purchased with estimated costs(s)
- 3. Description of upgrade(s)
- 4. Description of how this will improve the efficiency of processing activities and/or increase volume

### Upon approval of application:

- 1. Applicant should complete planned improvement, purchase equipment, etc.
- 2. Once improvement is complete, applicant may submit for reimbursement. Reimbursement requires:
  - Actual/copies of receipts, expenses or invoices paid
  - Completed IRS W9 form
