  - c. When did you get started? How has your company developed over the years?
- 4. Things to think about;
  - a. How do you want Pride of Dakota customers contacting you?
    - i. Phone
    - ii. Email
      - 1. Do you have a business address?
      - 2. Is the address professional and relevant to your business?
  - b. What email address do you want Pride of Dakota staff contacting you at?
    - i. It can be different than the customer email
  - c. Do you have a website?
    - i. It is not required
    - ii. Only create one if you are going to update it and do it well
    - iii. You can use a URL link to your business Facebook page

There is a \$100 annual membership fee due every January 1st; this fee is not pro-rated.



## **Food Businesses**

#### If your food company is looking to sell retail:

- 1. The food products must be made in an inspected kitchen
- 2. You should work closely with your local food unit
- 3. You must establish Hazard Analysis Critical Control Point (HACCP) for the control of food safety hazards



Cottage Food: Sales direct to the consumer

The North Dakota Cottage Food Production and Sales Law allows for the sale of uninspected, homemade cottage food products to an informed end consumer for at-home consumption.

## **Registration Checklist**

- Create a North Dakota Login: This login will be used for your North Dakota Secretary of State registration, Sales Tax ID and Pride of Dakota website
- Register with the North Dakota Secretary of State: All trade names must be registered with the North Dakota Secretary of State before doing business in North Dakota according to the North Dakota Century Code Chapter 47-25, Trade Names
- Obtain a North Dakota Sales Tax ID (food companies do not need to register for a sales tax ID)

Once all boxes have been checked, move on to the application process.
